October and November were very busy months for us as we held our second Annual Seminar, General Assembly and Steering Committee meeting, but at the same time we also published a <u>position paper on</u> <u>solitary confinement</u> and prepared for our first <u>Child Justice Caravan</u> this coming weekend which will see young people attend meetings at the European Commission and the European Parliament.

The highlight of the period was definitely our Annual Seminar 2023 "Transforming Justice Systems for Children in Migration" held in Genoa, Italy, on 26 and 27 October 2023 which brought together around one hundred participants. Every year we hold an <u>Annual</u> <u>Seminar on child friendly justice</u> in one of our members' countries to discuss child friendly justice with European experts. The General Objective of the 2023 Annual Seminar was to promote the human rights of children in migration in contact with justice systems and generate opportunities for collaborations among national and regional stakeholders to guarantee that children in migration can effectively access justice in Europe.

Save the date for the next seminar which will take place in Portugal in the second week of October 2024 and will focus on Children and Climate!

Policy Updates



EC Open consultation on the LGBTIQ equality strategy. The CFJ-EN provided inputs to the evaluation of the LGBTIQ Equality Strategy 2020-2025 of the European Commission, referring to our 2022 Challenge Paper 'Towards LGBTI+ sensitive justice systems for children in Europe'. It reminded the EC about the importance of gathering child justice and LGBTI+ experts and practitioners to examine the barriers that LGBTI+ children face when in contact with justice systems, and propose concrete actions to address these challenges.

Case Law



EUROPEAN COURT OF HUMAN RIGHTS COUR EUROPÉENNE DES DROITS DE L'HOMME

ECtHRC, Case A.D. v. Malta (2023) - Conditions of detention in various immigration centres of a vulnerable individual, due to presumed minority and health situation. The case concerns the holding of the applicant, a vulnerable individual due to his alleged minority and health situation, in different detention centres for different purposes over several months. The Court notes a violation of Article 3 in respect of the conditions of detention of the applicant (a vulnerable individual due to his presumed minority and health situation), as well as of Article 5 § 1, inter alia, in relation to his prolonged immigration detention in those conditions.

ECtHRC, Case C. v. Italy (2023) - Surrogacy Arrangements.

On 31 August 2023, in the case of C. v. Italy, the European Court of Human Rights (ECtHR) delivered a judgment concerning a four-yearold child born via a gestational surrogacy arrangement in Ukraine and subsequently deemed stateless in Italy. This judgment prompts reflection on surrogacy as a potential (indirect) contributor to statelessness and on possible legal remedies to avert new incidents of statelessness.

Upcoming and Recent Events



First CFJ-EN Child Justice Caravan. The first-ever Child Justice Caravan of the CFJ-En will take place from 2-5 December in Brussels, in collaboration with members DCI Greece and HOPE. It is an initiative proposed by the Network to children and young people to visit European institutions, meet with key representatives from these institutions and become advocates for change in European systems of justice and have their rights and needs better respected.

LBI-GMR Webinar - Disciplinary Sanction Regimes in Youth Detention Facilities. On 24 November 2023, LBI-GMR in collaboration with CREAN organised a very successful webinar where our coordinator Mariama Diallo delivered a session on "Applying Child-centred Justice in Detention Facilities – a Reality Check from the Field". A great opportunity to launch our recent <u>publication on</u> Solitary Confinement.

The Role of Local Authorities in empowering children in migration. On 22 November 2023, the Cities and Regions for Integration of Migrants network of the European Committee of the Regions held the seminar "World Children's Day: the role of local authorities in protecting and empowering migrant and refugee children". Organised in close cooperation with UNICEF, the seminar focused on ensuring the necessary capacity-building, and the exchange of best practices among cities and regions involved in vulnerable child protection in the context of migration.

European Day on the Protection of Children against Sexual Exploitation and Sexual Abuse. Each year, the Council of Europe invites its partners to focus on a specific topic on the occasion of the European Day. The 2023 edition of the European Day on 18 November focused on "Learning from victims/survivors of childhood sexual violence to inspire policy change".

Global: Enforcing the Rights of Children in Migration

The ILA Study Group initiated its work by establishing key principles, including non-discrimination and the best interests of the child, to guide state practices regarding children in migration. It highlighted common rights violations such as arbitrary age assessments and inadequate reception policies, employing a multidisciplinary approach to demonstrate the harmful effects on child health. The study also assessed international instruments, legal fora, and jurisprudence, identifying gaps and formulating recommendations to empower migrant children in enforcing their rights and accessing justice.

28 Council of Europe member States have established Barnahus and/or Barnahus-type services, and five more States are in the process of setting up Barnahus. In about half of the States that do not yet have Barnahus or Barnahus-type services, there is an ongoing public debate and/or State and civil society actors are advocating for Barnahus. These numbers are clear signs of the enthusiasm that surrounds the Barnahus model in Europe, and of the felt positive impact of the Barnahus model on child victims and witnesses, which has been increasingly evidenced and recognised.
