The Seminar, taking place at the stunning Art-Nouveau Belgian Museum of Comic Strip Arts, integrated dynamic thematic workshops, each led by one CFJ-EN member, on children involved in administrative proceedings, intersectionality, the court practice in Germany, the impact of digital courts on child justice, the challenges in Europe children suspects or accused face in criminal proceedings and in civil and administrative proceedings.

With the election of our President Benoît van Keirsbilck and Vice-President Nantina Tsekeri, the adoption of our 2023-2025 Strategy and revised Membership Application Package, we can only be grateful to this vibrant community of Members, child justice practitioners, policy makers and the CFJ-EN operational Team to having made these events a success! Our 19 members gathered in person for the first time since the inception of the Network on 13 October in Brussels for a productive day of discussion and networking. On the occasion of the final iCare conference in September - co-led by our member DCI Italy - the publication International family mediation in the best interests of the child was launched as a methodology and orientations from a child-centred perspective, to professionals involved in mediation in cases of international child abduction.

Our partner in Cambodia, the Child Justice Network (NGO/UN partnership to enhance child justice systems), consulted the CFJ-EN to develop a Child-**Friendly Justice Terminology Guideline** to promote the wider use and proper understanding of child-friendly terms in relation to child justice, based on international and Cambodian laws and standards.
